CLAIM JUMPIN', HIGHGRADIN', & GENERAL MISBEHAVIN'

An open letter to the individuals misbehaving on the Club Claims --

Dear Claim Jumpers, Highgraders, Interlopers, and extended stay campers who are breaking Helena Mineral Society Policy, the Duties of Members Contract they signed, Montana Law, Federal Law, and in all likelihood IRS reporting requirements...

Let's be clear...we know who you are, we have pictures, we have screen shots of your social media posts, and we have documentation of you selling material from the Club claims. Please cease and desist your unlawful activities immediately. Thank you.

Now that the fun legal notice and disclaimer is out of the way, let's get to this months article – What on earth are Claim Jumping and Highgrading? Living in Montana, we often hear these terms bandied about as a part of our history but rarely give thought to the possibility that these things are still happening today. In the pecking order of historic western criminals, claim jumpers ranked just below horse thieves and were treated accordingly – they were the lowest of the low. Although the West of the Gold Rush years was a lawless and disordered place, one thing was always true and enforced across the territories - the right of a miner to pinpoint a mining claim, file it, and hold it against all comers.

There are, fundamentally, two ways to violate this sacred right – producing and selling minerals or products from a claim held by someone else, and/or attempting to physically or legally seize land on which another party has filed a claim. The first option is known as highgrading, the second as claim jumping. And while these definitions still stand, the terms are now completely intertwined in modern juris prudence. Both are as illegal today as they were during the founding days of our state. In addition to those two specific crimes, any and all of the following can be added to the charges depending which state you are in – Trespass, Mineral Trespass, Wrongful Abstraction of Ore by Trespass Workings, Wrongful Working of Minerals, Unauthorized Use, Wrongful Interference with Personal Property, Wrongful Conversion, Trespass and Conversion, and Willful Trespass. Another part of the fun legal wrangling is the environmental impact. Fines can be added to any or all of these charges if violations of state or federal environmental or mining laws are discovered during the investigation. And just to add insult to injury – if you used your beloved truck to get to the site or haul your ill-gotten wealth away it can be confiscated as part of the proceedings. And if you really want to have serious fun, sell the illegally acquired specimens and fail to report the income to the IRS...that is tax evasion.

In Montana there are a number of "Codes" that specifically reference these activities. Updated in 2023, Title 82 (Minerals, Oil, and Gas), Chapter 2 (Mining), Part 1 addresses the Filing of False Mining Claims. I won't bore you with all the legal wrangling but cut to the chase which states "...shall be punished by imprisonment in the state prison for not more than 5 years, by a fine of not more than \$5,000, or by both." Interestingly, because the trespassing add-on is actually a federal (read Bureau of Land Management or BLM) crime the monetary punishment is harsher – up to \$100,000 fine and up to 1 year in jail.

Duties of Members as they pertain to claim jumpin', highgradin', & general misbehavin'. <u>All individuals issued a membership card</u>, whether a single membership or under a family membership <u>are responsible for following these rules</u>. Members who invite guests to a claim or on a sponsored fieldtrip are responsible for the guests behavior.

Duties of Members

- a) It shall be the duty of each member to endeavor to attend each meeting of the Helena Mineral Society. Inc., to abide by the majority vote of the members and the decisions of the Board of Directors as expressed in Article III of the Articles of Incorporation.
- b) A member will respect the privacy of private property and will not enter on such property to collect specimens without the permission of the owner.
- c) A member will observe all rules and regulation applying to Federal and State lands when entering thereon to collect specimens.
- A member will not present himself or herself as acting for the Helena Mineral Society, Inc., unless so authorized.
- e) A member or guest shall not "undercut" or "tunnel" in excess of <u>one-foot from</u> <u>the vertical face</u> while attempting to recover any mineral or specimen on any Helena Mineral Society, Inc., claim or property.
- f) A member may not dig on any of the Helena Mineral Society. Inc.. claims more than three (3) consecutive days, nor more than a total of ten (10) days on any one claim during the calendar year. A day is herein defined as the time beginning at sunrise and ending at sunset, or any portion thereof. There will be no prospecting between the hours of sunset to sunrise and/or the use of any artificial light. All motor driven equipment is strictly prohibited on any and all Helena Mineral Society, Inc.. claims with the exception being for remediation and maintenance only.
- g) A member family may be accompanied by no more than one (1) non-member guest family while digging on the Helena Mineral Society. Inc., claims. Exceptions to this paragraph shall be by the approval of the Board of Directors. The Helena Mineral Society, Inc., claims presently consist of: The sapphire claims (Miss Beverly #1, Miss Beverly #2 & Blue Star) and the Crystal claim on Sally Ann Creek.
- h) No gem or mineral found on any Helena Mineral Society, Inc., claim may be sold in any commercial manner.
- A member on any Helena Mineral Society, Inc., claim shall have on his/her person a current membership card and shall display the same to any other member upon request.

Violations of these Duties and/or Rules shall be reviewed by the Board of Directors and will be cause for the withdrawal of membership of the violating member by the Helena Mineral Society, Inc.

Cadet, Missouri, and Brookite with Smoky Quartz near Magnet Cove, Arkansas. Along with her daughter and grandkids they collected at several sites within the boundaries of the Haunted Ridge Druzy Quartz Mine. The collecting was tons of fun but the seven hours of power washing that followed was perhaps not quite as fascinating. That said the results were fabulous – several distinct colorations can be found at different locations –

> the brown includes limonite and hematite, and the yellow is likely citrine but, at the mine, is referred to as "root beer" Quartz. The crystals are found on an agate base.






Notes from the June Club Meeting...

- ▶ Kim Peterson presented on her recent road trip to collect in Missouri and Arkansas.
- Discussion was held regarding paying fees and reimbursements to speakers who travel to present at club meetings. Curt provided a detailed sheet explaining the proposal. After in depth discussion the members voted to accept the proposal. The Club is hoping to bring in special speakers roughly three or four times per year to augment the speakers available locally.
- ▶ UV lights have been ordered. They will be available for purchase (\$20) at the picnic
- An honorarium for active committee leads and board members was discussed and passed these individuals will receive one free year of membership at whatever level they already are signed up for.
- The Club was offered the opportunity to purchase 55 gallon drums of Yogo Sapphire scraps. The members voted to explore purchasing two barrels of the material considering it a unique opportunity that should not be passed up. Gene will follow up regarding the purchase.
- Extensive discussion was held regarding what to do with the extra funds the Club has saved. Per the membership votes
 - The scholarship at Montana Tech in Butte will be raised to \$3,000 per year.
 - > The scholarship for Montana Learning Center will be raised to \$4,000 per year.
 - Work has begun on the format for the teacher mini-grants (\$500 to \$3,000). Details will be presented at a future membership meeting
- A reminder there is no membership meeting in July because of the Club Picnic July 13th.
- IMPORTANT NOTE If you still have yellow mineral society vests from the mineral show or other volunteer activities please return them to the club. The newly purchased vests are shared assets within the club and cannot be kept by individual members. 


Books of interest to the Montana Rockhound



Most recently updated in 2015, Falcon Guides' <u>Rockhounding Montana</u> is a foundational part of any resource collection on public and commercial sites to collect in our state. There are several older editions – some site information has changed as well as some access information. Please be sure you confirm your information before you set out. The guide also describes numerous little-known areas. For the novice it provides handy "how to's" for collecting specimens and includes maps and directions to each location. For the accomplished rockhound it can provide ideas for yet another fabulous weekend digging for treasures – it contains 100 localities. For those inclined to venture further afield, Falcon's Rockhounding Guides are available for 20 states and districts.


